

OFFICIAL RULES FOR THE BLENHEIM PAINTED 2016 SWEEPSTAKES  
NO PURCHASE NECESSARY TO ENTER OR WIN.

*By entering or participating in the Blenheim Painted 2016 Sweepstakes (the "Sweepstakes") you agree to all of the following rules:*

**How to Enter.** No purchase is necessary to enter the Sweepstakes. Each person that purchases a Painted **Wine or Merchandise** Bundles of 2015 Painted Red or 2015 Painted White wines online at [www.blenheimvineyards.com](http://www.blenheimvineyards.com) or in the Tasting Room at Blenheim Vineyards will be asked to provide their name, home address, telephone number, e-mail address and age and will be entered to win the Sweepstakes. Anyone may also enter the Sweepstakes by mailing a 3" x 5" postcard with sufficient postage containing the sweepstakes name, **Blenheim Painted 2016 Sweepstakes**, which must be exact, your name, home address, telephone number, e-mail address and age to 31 Blenheim Farm, Charlottesville, Virginia 22902. Any error or omission in an entry will void the entry. Limit one (1) entry per individual. Limit one (1) entry per post card. By participating, all entrants agree to abide by these Official Rules.

**Eligibility.** The Sweepstakes is open to legal residents of the 50 United States and the District of Columbia over the age of eighteen (18). Proof of age may be required. Employees of Blenheim Vineyards ("administrator") and its affiliates, employees of any prize sponsor and its affiliates, and members of such employees' immediate families (their parents, spouses, siblings (natural born or adopted), children (natural born or adopted)) or households are ineligible to participate in the Sweepstakes.

**Prize Deadlines.** All entries for the Sweepstakes must be received by Friday, December 9th, 2016 at 5:00 p.m. EST. Winner will be selected from a random drawing.

**Winner Selection and Notification.** The odds of winning are dependent upon the number of eligible entries received.
